CHAPTER 4 - RECREATION PERMITS

ARTICLE 1 - NONMEMBER HUNTING PERMITS

Legislative History: Ordinance No. 32, governing the issuance of hunting permits to nonmembers, was enacted by the Papago Council on April 4, 1958 and approved by the Papago Agency Superintendent on April 11, 1958.

Related History: Ordinance No. 32 was suspended by Resolution No. 15-148, "Suspending 19 Tohono O'odham Code Chapter 4, Article 1 - Nonmember Hunting Permits and Establishing Moratorium on Hunting by Nonmembers" effective May 15, 2015 until May 17, 2017.

ORDINANCE
OF THE
PAPAGO COUNCIL

Ord. No. 32

WHEREAS, the Papago Tribal Council receives many applications from non-members of the Papago Tribe for permission to come upon the Reservation and hunt for all sorts of game, and

WHEREAS, the Papago Tribal Council believes permits should be issued and fees collected for this privilege,

THEREFORE, LET IT BE ORDAINED that the Chairman of the Tribal Council or the Tribal Treasurer be authorized to issue such permits to non-members desiring this privilege on the terms and conditions as specified herein:

1. A Tribal hunting license shall cost ^{Now \$25} ~~\$10.00~~. It may be issued at any time but shall expire on ~~June 30~~ ^{the date} of each year. It will permit the hunting of all wild fowl and game, ~~except~~ mountain sheep, all species of deer, and javalina. It shall be issued subject to the following conditions to which licensee agrees:

- a. In addition to carrying a tribal hunting license on the person while hunting, licensee must also have in his possession a valid Arizona State hunting license.
- b. To comply with all Federal and State game laws and Papago bag limits.
- c. To comply with all Federal laws prohibiting the introduction, sale, possession, gift, or manufacture of alcoholic drinks on Indian Reservations.
- d. To refrain from shooting in the vicinity of any house, village, person, or livestock.
- e. To respect the rights of others.
- f. To obtain permission from the owner before hunting on fenced allotments within the San Xavier reservation.
- g. The license is not transferable.

Any person violating any provisions of this ordinance shall have his hunting license cancelled. Such person shall also be deemed a trespasser on the Papago Reservation pursuant to Chapter 6, Section 1 of the Papago Tribal Law and Order Code, and in addition shall also be required to surrender any game in their possession.

The supplementary Ordinance was on April 8, 1958 duly enacted by a vote of 21 for and 0 against, at a meeting at which a quorum was present, pursuant to authority vested in it by Section 3 (b) (h) of Article V of the Constitution of the Tribe ratified December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934, (48 Stat, 984). Said Ordinance is effective as of the date of its approval by the Superintendent of the Papago Agency, subject to its rescission by the Secretary of the Interior pursuant to Section 6, Article V, of the Constitution and By-laws of the Papago Tribe,
