

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Amendment No. 1 to the FY 2011 Budget of the Office of Attorney General)**

RESOLUTION NO. 11-027

1 WHEREAS, the Office of Attorney General has an approved budget for FY2011 in the amount of  
2 \$1,674,426.69; and

3 WHEREAS, the attached Amendment No. 1 to the FY 2011 budget of the Office of Attorney General,  
4 budget No. 01-1031, ("Amendment No. 1") adds \$10,000 to line 810, Professional  
5 Services, for additional funds for attorney contracts; and

6 WHEREAS, the source of funds for this Amendment No. 1 is from the FY2011 general fund surplus;  
7 and

8 WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed Amendment  
9 No. 1, and recommend approval by the Tohono O'odham Legislative Council.

10 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves  
11 Amendment No. 1 in the amount of \$10,000 for budget No. 01-1031, from the FY2011  
12 general fund surplus, changing the budget total from \$1,674,426.69 to a new total of  
13 \$1,684,426.69.

14 BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council appropriates the amount  
15 of \$10,000 from the FY 2011 general fund surplus to fund Amendment No. 1.

16 BE IT FINALLY RESOLVED the Tohono O'odham Legislative Council hereby authorizes the  
17 Chairperson and any designated official to expend and administer the budget as  
18 attached, provided that any amendments affecting the funds or funding level shall  
19 be submitted for further prior approval by the Tohono O'odham Legislative Council.

20 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21<sup>ST</sup> Day  
21 of JANUARY, 2011 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-  
22 AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by Article  
23 VI, Section 1 (d)(3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono  
24 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
25 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
26 Stat. 984).
