

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the Certification of Additional Tohono O'odham Nation Eligible Adult  
Members for the Fourth Per Capita Distribution)**

**RESOLUTION NO. 11-041**

1 **WHEREAS, on June 28, 1997, the Nation's voters approved Initiative No. IN-01-97, the "Tohono**  
2 **O'odham Voice in the Use of Gaming Revenues" ("Initiative"), which authorizes per**  
3 **capita payments to the Nation's members provided that sufficient gaming revenues**  
4 **are available; and**

5 **WHEREAS, the Ordinance for the Regulation of Gaming Activities within the Tohono O'odham**  
6 **Nation ("Gaming Ordinance") was subsequently amended to authorize per capita**  
7 **distribution payments in accordance with the Initiative (See Legislative Council**  
8 **Resolution No. 97-303); and**

9 **WHEREAS, the Legislative Council adopted the Per Capita Revenue Allocation Plan for a per**  
10 **capita distribution per Legislative Council Resolution No. 09-164 ; and**

11 **WHEREAS, the Chairman of the Nation received written notification from the Department of the**  
12 **Interior on June 15, 2009 that the Nation's Revenue Allocation Plan is approved; and**

13 **WHEREAS, the Nation's Department of Membership Services, Enrollment Program submits to the**  
14 **Tohono O'odham Legislative Council the certification Listing for eligible adult**  
15 **members for review and approval for a fourth per capita distribution; and**

16 **WHEREAS, pursuant to Resolution No. 09-428 which approved the Master List for certification,**  
17 **the initial number of verified adult eligible members for the fourth per capita**  
18 **distribution is 19,141; and**

19 **WHEREAS, the disbursement of funds to each eligible adult member is contingent upon**  
20 **verification of a member and further certification by the Tohono O'odham Legislative**  
21 **Council.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
23 **the certification of 13 additional adult members for the fourth per capita distribution.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup> Day**  
25 **of FEBRUARY, 2011 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**  
26 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article**  
27 **VI, Section 1 (d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
28 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
29 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
30 **Stat. 984).**
