

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Sells District Administration FY2011 Budget Amendment #1)**

RESOLUTION NO. 11-113

1 **WHEREAS, Tohono O'odham Legislative Council Resolution No. 10-387 approved the Sells District**
2 **Administration Budget in the amount of \$1,705,922.80 from the Tohono O'odham**
3 **Nation's Gaming Revenues; and**

4 **WHEREAS, the Sells District Administration has identified the need to amend the FY2011 budget**
5 **to assure that line items within the budget are not over expended and to assure that**
6 **the District can continue to address the needs of its membership and the operations**
7 **of the Administration; and**

8 **WHEREAS, Amendment #1 will address the need to increase Occasional Appointments, Building**
9 **Materials, Repair & Maintenance of Vehicles, Professional Services, and Special**
10 **Activities; and**

11 **WHEREAS, Amendment #1 will decrease the Line Items for District Bonus, Major Capital,**
12 **Construction, and the Reserve for Contingencies; and**

13 **WHEREAS, Amendment #1 to the FY2011 Sells District Administration Budget and its Justification**
14 **has been reviewed and approved by Sells District Council Resolution #SD-14-11.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
16 **the Sells District FY2011 Budget Amendment #1 and its Justification as attached**
17 **Increasing Line Item 612 Occasional Appointments by \$5,500.00; Line Item 727**
18 **Building Materials by \$10,000.00; Line Item 771 Repair & Maintenance of Vehicles by**
19 **\$5,000.00; Line Item 810 Professional Services by \$15,000.00; Line Item 860 Special**
20 **Activities by \$5,000.00.**

21 **BE IT FURTHER RESOLVED that these Increases will Decrease Line Item 624 District Bonus by**
22 **\$900.00; Line Item 750 Major Capital by \$10,000.00; Line Item 779 Construction by**
23 **\$24,600.00; Line Item 780 Reserve for Contingencies by \$5,000.00, with no changes to**
24 **the total budgeted amount of \$1,705,922.80.**

25 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the Sells**
26 **District Chairperson and any designated official to expend and administer the budget**
27 **according to its justification, as attached, provided that any modifications or**
28 **amendments affecting the funds or funding levels of the budget shall be submitted for**
29 **further prior approval by the Tohono O'odham Legislative Council.**
