LEGISLATIVE ORDER NO. 11-154

3	that the "decision of the Tohono O'odham Council in all election matters, including

5	Section 1(g) and Article X, Section 7); and
6	WHEREAS, during the May 23, 2009 general election, Frederick Jose was elected to the Legislative
7	Council alternate seat for Schuk Toak District; and
8	WHEREAS, Frederick Jose resigned his alternate seat effective April 14, 2011 and the Schuk Toak
9	District approved his appointment as a representative on the Legislative Council
10	(Schuk Toak District Council Resolution No. ST-04-14-11-63); and
11	WHEREAS, on April 14, 2011, following Phyllis Cachora's resignation from office as Santa Rosa
12	Ranch Community Representative, the Schuk Toak District Council approved the
13	appointment of Phyllis Cachora to serve as Frederick Jose's alternate on the
14	Legislative Council (Schuk Toak District Council Resolution No. ST-04-14-11-64); and
15	WHEREAS, the Legislative Council, as a means of ensuring that each district is fully represented
16	on the Legislative Council, has recognized district council appointments to vacant
17	alternate seats in instances where vacancies have occurred outside of circumstances
18	expressly outlined in the Uniform Election Ordinance for filling vacancies.

23	the unexpired term of her predecessor.
24 25 26 27 28 29 30	The foregoing Order was passed by the Tohono O'odham Legislative Council on the <u>25TH</u> day of <u>APRIL, 2011</u> at a meeting at which a quorum was present with a vote of <u>2,595.50</u> FOR; <u>-0-AGAINST</u> ; <u>-0-NOT VOTING</u> ; and <u>[02]</u> ABSENT, pursuant to the powers vested in the Council by Section 1 (g) of Article VI and Section 7 of Article X of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
