

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Recognizing the Schuk Toak District Council Appointment of Phyllis Cachora
as Alternate to Legislative Council Representative Frederick Jose)

LEGISLATIVE ORDER NO. 11-154

1 **WHEREAS, the Constitution of the Tohono O'odham Nation empowers the Legislative Council to**
2 **“enact laws and ordinances for conducting and regulating elections” and provides**
3 **that the “decision of the Tohono O'odham Council in all election matters, including**
4 **the eligibility and qualifications of candidates, shall be final” (Constitution, Article VI,**
5 **Section 1(g) and Article X, Section 7); and**

6 **WHEREAS, during the May 23, 2009 general election, Frederick Jose was elected to the Legislative**
7 **Council alternate seat for Schuk Toak District; and**

8 **WHEREAS, Frederick Jose resigned his alternate seat effective April 14, 2011 and the Schuk Toak**
9 **District approved his appointment as a representative on the Legislative Council**
10 **(Schuk Toak District Council Resolution No. ST-04-14-11-63); and**


11 **WHEREAS, on April 14, 2011, following Phyllis Cachora's resignation from office as Santa Rosa**
12 **Ranch Community Representative, the Schuk Toak District Council approved the**
13 **appointment of Phyllis Cachora to serve as Frederick Jose's alternate on the**
14 **Legislative Council (Schuk Toak District Council Resolution No. ST-04-14-11-64); and**

15 **WHEREAS, the Legislative Council, as a means of ensuring that each district is fully represented**
16 **on the Legislative Council, has recognized district council appointments to vacant**
17 **alternate seats in instances where vacancies have occurred outside of circumstances**
18 **expressly outlined in the Uniform Election Ordinance for filling vacancies.**

19 **NOW, THEREFORE, BE IT ORDERED by the Legislative Council that it (1) affirms Schuk Toak District**
20 **Council Resolution No. ST-04-14-11-64 appointing Phyllis Cachora to serve as alternate**
21 **to Representative Frederick Jose and (2) seats Phyllis Cachora to fill the vacancy left**
22 **by former Alternate Frederick Jose, provided that Phyllis Cachora shall hold office for**
23 **the unexpired term of her predecessor.**

24 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 25TH day of**
25 **APRIL, 2011 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;**
26 **-0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1 (g) of**
27 **Article VI and Section 7 of Article X of the Constitution of the Tohono O'odham Nation, adopted by**
28 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
30 **18, 1934 (48 Stat. 984).**


