

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Recognizing the Schuk Toak District Council Appointment of Stanley Stephens
as Alternate to Legislative Council Representative Frances Conde)**

LEGISLATIVE ORDER NO. 11-155

1 **WHEREAS, the Constitution of the Tohono O'odham Nation empowers the Legislative Council to**
2 **“enact laws and ordinances for conducting and regulating elections” and provides**
3 **that the “decision of the Tohono O'odham Council in all election matters, including**
4 **the eligibility and qualifications of candidates, shall be final” (Constitution, Article VI,**
5 **Section 1(g) and Article X, Section 7); and**

6 **WHEREAS, during the 2009 general election, Frances Conde was elected to the open Legislative**
7 **Council representative seat and Frederick Jose was elected to the alternate**
8 **representative seat for Schuk Toak District; and**

9 **WHEREAS, Frederick Jose resigned his alternate seat effective April 14, 2011 thereby creating a**
10 **vacancy in the alternate representative seat; and**

11 **WHEREAS, on April 14, 2011, the Schuk Toak District Council approved the appointment of**
12 **Stanley Stephens to serve as Representative Frances Conde's alternate on the**
13 **Legislative Council (Schuk Toak District Council Resolution No. ST-04-14-11-61); and**

14 **WHEREAS, the Legislative Council, as a means of ensuring that each district is fully represented**
15 **on the Legislative Council, has recognized district council appointments to vacant**
16 **alternate seats in instances where vacancies have occurred outside of circumstances**
17 **expressly outlined in the Uniform Election Ordinance for filling vacancies.**

18 **NOW, THEREFORE, BE IT ORDERED by the Legislative Council that it (1) affirms Schuk Toak District**
19 **Council Resolution No. ST-04-14-11-61 appointing Stanley Stephens to serve as**
20 **alternate to Legislative Council Representative Frances Conde and (2) seats Stanley**
21 **Stephens on the Legislative Council to fill the vacancy left by former alternate**
22 **Frederick Jose, provided that Stanley Stephens shall hold office for the unexpired term**
23 **of his predecessor**

24 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 25TH day of**
25 **APRIL, 2011 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;**
26 **-0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1 (g) of**
27 **Article VI and Section 7 of Article X of the Constitution of the Tohono O'odham Nation, adopted by**
28 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
30 **18, 1934 (48 Stat. 984).**
