2 **Nation's FY2010 Single Audit as required by the Single Audit Act; and**

3 **WHEREAS, the Auditors have completed the FY2010 Single Audit Act Reports and Basic Financial**
4 **Statements and Independent Auditors' Report, Single Audit Report and Management**
5 **Letter for the year ended September 30, 2010; and**

6 **WHEREAS, the Chairman of the Nation and the Budget & Finance Committee have reviewed the**
7 **following FY2010 Single Audit Act Reports, Basic Financial Statements and**
8 **Independent Auditors' Report, Single Audit Report and Management Letter.**

9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council accepts and**
10 **approves the FY2010 Audit Reports required by the Single Audit Act, which include the**
11 **Basic Financial Statements and Independent Auditors' Report, Single Audit Report**
12 **and Management Letter for the year ended September 30, 2010.**

13 **BE IT FINALLY RESOLVED that approval is hereby granted to the Chairman and Vice-Chairman of**
14 **the Nation to release the approved Basic Financial Statements and Independent**
15 **Auditors' Report, Single Audit Report and Management Letter for year ending**
16 **September 30, 2010 to the Federal Clearinghouse and respective agencies.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 25TH Day**
18 **of MAY, 2011 at a meeting at which a quorum was present with a vote of 2,408.40 FOR; -0- AGAINST;**
19 **-0- NOT VOTING; and 187.10 [07] ABSENT, pursuant to the powers vested in the Council by Article**
20 **VI, Section 1 (d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
21 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
22 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
23 **Stat. 984).**
