

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2011 Kitt Peak Wildland Urban Interface Project Amendment No. 1 )**

**RESOLUTION NO. 11-202**

1 **WHEREAS, the Tohono O'odham Nation operates a Wildland Fire Management Program within**  
2 **the Tohono O'odham Fire Department funded by Bureau of Indian Affairs under P.L.**  
3 **93-638 Master Contracts No. 1450CTH54T61071, to provide services in fire suppression,**  
4 **prevention, and preparedness on the Nation's lands; and**

5 **WHEREAS, the Nation's Wildland Fire Management Program along with the State and Federal**  
6 **agencies, which include the following: Bureau of Indian Affairs, U.S. Fish and Wildlife**  
7 **Service, Bureau of Land Management, U.S. Forest Service, National Science**  
8 **Foundation, and Arizona State Land Department is developing the Kitt Peak Wild land**  
9 **Urban Interface Project to address the Risk of wild fires occurring on Kitt Peak; and**

10 **WHEREAS, the Kitt Peak Wildland Urban Interface Project, will utilize the Nation's Wildland Fire**  
11 **Management Program personnel and equipment, along with the personnel and**  
12 **equipment of other agencies to remove fuels surrounding the Kitt Peak mountain**  
13 **range which will decrease the risk of catastrophic impact from potential wild fires and**  
14 **protect lives, property and natural resources; and**

15 **WHEREAS, the Wildland Fire Management Program is adding new line item 750- Major Capital to**  
16 **purchase a Vermeer Wood chipper that would be utilized for the Kitt Peak Wildland**  
17 **Urban Interface Project and other Fuel Reduction Projects on the Tohono O'odham**  
18 **Nation; and**

19 **WHEREAS, the Domestic Affairs Committee and the Budget and Finance Committee have**  
20 **reviewed the attached budget Modification and recommend approval by the**  
21 **Legislative Council.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Legislative Council approves adding the new line item**  
23 **750-Major Capital, and the Kitt Peak Wildland Urban Interface Project attached FY**  
24 **2011 Budget Amendment No. 1 in the amount of \$353,673.00 and authorize the**  
25 **program to expend funds as budgeted.**

26 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council hereby authorizes the**  
27 **Chairperson and any designated official to expend and administer the budget, as**  
28 **attached, amendments affecting the funds or funding levels of the budget shall be**  
29 **submitted for further prior approval by this Council.**

30 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 26<sup>TH</sup> Day**  
31 **of MAY, 2011 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;**  
32 **-0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article VI,**  
33 **Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham**  
34 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
35 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


