1 **WHEREAS, the Tohono O'odham Nation has successfully operated the Senior Services program**
2 **for the Elders of the Nation; and**

3 **WHEREAS, funding for period July 1, 2011 through June 30, 2012 for the operation of the Senior**
4 **Services Program is possible in part by Title III of the Older Americans Act funds**
5 **administered through the Inter-Tribal Council of Arizona (ITCA); and**

6 **WHEREAS, the services provided to the Elders and Caregivers are beneficial and services continue**
7 **to be necessary in order to provide nutrition and transportation support to the Elders;**
8 **and Caregiver support to the Caregivers of Elder and Elders raising Grandchildren;**
9 **and**

10 **WHEREAS, the fiscal year 2012 Title III-B \$27,961.00; C-1 \$87,420.00; C-2 \$42,845.00 program**
11 **budgets were prepared to continue nutrition, socialization and transportation**
12 **services to eligible Elders; and**

13 **WHEREAS, the fiscal year 2012 Title III E \$32,443.00 budget was prepared to provide support**
14 **services to current and potential Caregivers who provide care services for Elders and**
15 **to Elders who care for grandchildren; and**

16 **WHEREAS, the fiscal year 2012 Title III Nutrition Services Incentive Program (NSIP) \$7,219.00**
17 **budget was prepared to provide nutrition services to eligible Elders; and**

18 **WHEREAS, the fiscal year 2012 State Funds \$20,737.00 budget was prepared to support the Title**
19 **III B; Title III C-1 and Title III C-2 budgets for the Congregate Meals; Home Delivered**
20 **Meals and Transportation services; and**

21 **WHEREAS, the Health and Human Services Committee and the Budget and Finance Committee**
22 **of the Legislative Council have reviewed this budget and recommend its approval and**
23 **adoption.**

24 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
25 **approves:**

- 26 **1. The fiscal year 2012 Title III-B \$27,961.00; C-1 \$87,420.00; C-2 \$42,845.00 program**
27 **budgets to continue nutrition, socialization and transportation services to eligible**
28 **Elders.**

2. The fiscal year 2012 Title III E \$32,442.00 budget to continue to provide support services to current and potential Caregivers who provide care services for Elders and to Elders who care for grandchildren.
3. The fiscal year 2012 Title III Nutrition Services Incentive Program (NSIP) budget of \$7,219.00 to continue to provide nutrition services to eligible Elders.
4. The fiscal year 2012 State Funds budget in the amount of \$20,737.00 to support the Title III B; Title III C-1 and Title III C-2 budgets for Congregate Meal; Home Delivered Meal and Transportation services.
5. To utilize the Nation's resources pending reimbursement from the Inter-Tribal Council of Arizona (ITCA) for the continuation of the agreement.

BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the Chairperson and any designated official to expend and administer the budget as attached, provided that any amendments affecting the funds or funding level is submitted for further prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20th Day of JUNE, 2011 at a meeting at which a quorum was present with a vote of 2,568.70 FOR; -0- AGAINST; -0- NOT VOTING; and 211.90[03] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
