RESOLUTION NO. 11-267

1 **WHEREAS, by Resolution Number 10-296, all tribal budgets were approved by the Tohono**
2 **O'odham Legislative Council which included the FY 2011 Department of Health and**
3 **Human Services, Family Assistance tribal budget Account No. 01-1300; and**

4 **WHEREAS, the Department of Health and Human Services, recognizes the rising need and cost**
5 **for children in care; and**

6 **WHEREAS, the Department of Health and Human Services has prepared the attached FY**
7 **2011 Family Assistance 01-1300 Budget Amendment #1, which increases line item 864**
8 **by \$1,500,000.00 for a revised budget total of \$3,029,743.00; and**

9 **WHEREAS, the projection for FY 2011 is based on actual expenditures from October 1, 2010**
10 **through March 30, 2011; and**

11 **WHEREAS, the Executive Branch developed and obtained committee approval of FY 2011 Family**
12 **Assistance Budget Amendment No. 1 to increase line item 864 by \$1,500,000.00 for a**
13 **revised budget total of \$3,029,743.00 which is attached and incorporated by this**
14 **reference, to be effective October 1, 2010 through September 30, 2011 and requests**
15 **authorization to expend funds.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
17 **appropriate \$1,500,000.00 from the surplus funds and approves and authorizes the**
18 **Executive Branch to expend funds for the attached FY 2011 Family Assistance Budget**
19 **Amendment No. 1 to increase line item 864 Child Welfare Assistance by \$1,500,000.00**
20 **for a budget total of \$3,029,743.00 effective October 1, 2010 through September 30,**
21 **2011.**

22 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation Legislative Council hereby authorizes**
23 **the Chairperson and any designated official to expend and administer the budget as**
24 **attached, provided that any budget amendments affecting the funds or funding**
25 **levels shall be submitted for further prior approval by the Tohono O'odham**
26 **Legislative Council.**
