1 **WHEREAS, the Schuk Toak District presented to the Tohono O'odham Legislative Council the**  
2 **District's FY 2010 Carry Forward Amounts; and**

3 **WHEREAS, the Schuk Toak District was allocated Gaming Revenue in the amount of**  
4 **\$1,705,922.80 for FY 2011 and by adding the FY 2010 Carry Forward amounts, the new**  
5 **amount will be \$3,269,727.42; and**

6 **WHEREAS, the Schuk Toak District Council at a meeting held on June 25, 2011 with a quorum**  
7 **present, did review and approve the District FY 2010 Carry Forward funds; and**

8 **WHEREAS, the following nine communities did present their FY 2010 Carry Forward budgets as**  
9 **part of the new total FY 2011 District Budgets:**

29 **revised to a new total of \$100,140.00; and**

30 **WHEREAS, the total FY 2010 Carry Forward amount for the District Administration is**  
31 **\$1,240,774.21, which includes the remainder of \$19,982.71 from the FY 2010 Summer**  
32 **Youth Program Carry Forward to be incorporated into the current FY 2011 District**

27 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council approves the total FY**  
28 **2010 Carry Forward amount for the District Administration at \$1,240,774.21, which**  
29 **includes the remainder of \$19,982.71 from the FY 2010 Summer Youth Program**  
30 **Carry Forward to be incorporated into the current FY 2011 District Administration**  
31 **Budget amount of \$825,096.80, bringing it to a new total of \$2,065,871.01.**

5 **FY 2010 Carry Forward amount of \$1,563,804.62 to be incorporated into the FY 2011**  
6 **Schuk Toak District budget, changing the amount from \$1,705,922.80 to**  
7 **\$3,269,727.42 to be expended accordingly to attached budgets.**

8 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
9 **Nation's Officials, to wit; Chairperson, Vice Chairperson and any official appointed**  
10 **designee is hereby authorized to execute the budget, provided however, that any**  
11 **amendments affecting the funding or funding level of this budget shall be submitted**  
12 **for further prior approval by this council.**

13 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06<sup>TH</sup> Day**  
14 **of JULY, 2011 at a meeting at which a quorum was present with a vote of 2,553.90 FOR; -0- AGAINST;**  
15 **-0- NOT VOTING; and 226.70[03] ABSENT, pursuant to the powers vested in the Council by Article**  
16 **VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the**  
17 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
18 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
19 **18, 1934 (48 Stat. 984).**
