6	WHEREAS, the Legislative Branch FY 2011 Budget Modification 4/Amendment No. 2 in the amoun
7	of \$59,817.92 which provides for additional personnel and operational expenses and
8	does not change the approved FY 2011 Legislative Branch budget total amount o
9	\$3,269,563.62; and
10	WHEREAS, Legislative Branch FY 2011 Budget Modification 4/Amendment No. 2 would increase
11	line items 655-Lodging by \$27,633.96; 660-Travel by \$28,183.96; and 852-
12	Donation/Contributions by \$4,000; and
13	WHEREAS, there are sufficient funds in the Legislative Branch FY 2011 budget to support the
14	proposed Legislative Branch FY 2011 Budget Modification 4/Amendment No. 2; and
15	WHEREAS, the Legislative Branch FY 2011 Budget Modification 4/Amendment No. 2 has been
16	reviewed by the Budget and Finance Committee.
17	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby
18	approves Legislative Branch FY 2011 Budget Modification 4/Amendment No. 2 in the
19	amount of \$59,817.92 to increase line items; 655-Lodging by \$27,633.96; 660-Travel by
20	\$28,183.96; and 852-Donation/Contributions by \$4,000.00 and does not change the
21	approved FY 2011 Legislative Branch budget total amount of \$3,269,563.62.
22	BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it authorizes the
23	Legislative Council Chairperson and Vice-Chairperson to administer the attached
24	budget, provided however, that any amendments that change the aggregate total of
25	funds originally budgeted or that change the purpose for which the funds were
26	budgeted shall be submitted for prior approval by the Tohono O'odham Legislative
27	Council.
