

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Legislative Branch FY 2011 Budget Modification 4/Amendment No. 2)**

**RESOLUTION NO. 11-305**

1 **WHEREAS, the Legislative Council is authorized "to manage any funds within the exclusive**  
2 **control of the Tohono O'odham Nation . . . and to appropriate these funds for the**  
3 **benefit of the nation and its members "provided that" [a]ll expenditures of these funds**  
4 **shall be pursuant to appropriations or budgets" authorized by resolution or**  
5 **ordinance (Constitution of the Tohono O'odham Nation, Article VI, Section 1(d)(2)); and**

6 **WHEREAS, the Legislative Branch FY 2011 Budget Modification 4/Amendment No. 2 in the amount**  
7 **of \$59,817.92 which provides for additional personnel and operational expenses and**  
8 **does not change the approved FY 2011 Legislative Branch budget total amount of**  
9 **\$3,269,563.62; and**

10 **WHEREAS, Legislative Branch FY 2011 Budget Modification 4/Amendment No. 2 would increase**  
11 **line items 655-Lodging by \$27,633.96; 660-Travel by \$28,183.96; and 852-**  
12 **Donation/Contributions by \$4,000; and**

13 **WHEREAS, there are sufficient funds in the Legislative Branch FY 2011 budget to support the**  
14 **proposed Legislative Branch FY 2011 Budget Modification 4/Amendment No. 2; and**

15 **WHEREAS, the Legislative Branch FY 2011 Budget Modification 4/Amendment No. 2 has been**  
16 **reviewed by the Budget and Finance Committee.**

17 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
18 **approves Legislative Branch FY 2011 Budget Modification 4/Amendment No. 2 in the**  
19 **amount of \$59,817.92 to increase line items; 655-Lodging by \$27,633.96; 660-Travel by**  
20 **\$28,183.96; and 852-Donation/Contributions by \$4,000.00 and does not change the**  
21 **approved FY 2011 Legislative Branch budget total amount of \$3,269,563.62.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it authorizes the**  
23 **Legislative Council Chairperson and Vice-Chairperson to administer the attached**  
24 **budget, provided however, that any amendments that change the aggregate total of**  
25 **funds originally budgeted or that change the purpose for which the funds were**  
26 **budgeted shall be submitted for prior approval by the Tohono O'odham Legislative**  
27 **Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14<sup>th</sup> Day**  
29 **of JULY, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**  
30 **-0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)**  
31 **and (3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
32 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
33 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
34 **Stat. 984).**
