

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Sanitation Facilities Deficiency System Priority Ranking)**

RESOLUTION NO. 11-363

1 **WHEREAS, Indian Health Service, Division of Environmental Health and Engineering (DEH&E)**
2 **conducts an assessment of Sanitation Facilities Deficiencies, annually; and**

3 **WHEREAS, the Division of Environmental Health and Engineering assessment does have an**
4 **impact upon congressional appropriations and IHS allocation of funds; and**

5 **WHEREAS, Indian Health Service has provided for Tribal Priority ranking of the four (4) most**
6 **critical projects and does allocate points impacting upon overall prioritization of**
7 **projects; and**

8 **WHEREAS, the Division of Environmental Health and Engineering has provided**
9 **recommendations to the Tohono O'odham Legislative Council regarding the most**
10 **critical needs.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council has reviewed**
12 **and approved the entire priority list and has determined that the following**
13 **deficiencies are the four most critical and desirable, in descending order of**
14 **prioritization:**

- 15 1. **Septic System Replacement**
- 16 2. **Jackrabbit Arsenic Removal - Treatment**
- 17 3. **San Xavier East Well - Arsenic**
- 18 4. **San Miguel Arsenic - Regionalization**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 02ND Day**
20 **of AUGUST, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
21 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
22 **Section 1 (j) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
23 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
25 **Stat. 984).**
