1 **WHEREAS, Tohono O'odham Legislative Council Resolution No. 11-307 approves FY 2012 District**
2 **Allocation and Apportionment of Gaming Revenues to Districts by equal distribution;**
3 **and**

4 **WHEREAS, Pisinemo District FY 2012 budget in the amount of \$1,660,996.79 was presented to the**
5 **Legislative Council for review, comment and recommendations; and**

6 **WHEREAS, the Pisinemo District FY 2012 budget was also taken out to the communities of San**
7 **Simon, Pisinemo, Santa Cruz, Kupk and Dirtburn for review and comments and then**
8 **brought back to the Pisinemo District Council for action; and**

9 **WHEREAS, the respective communities and Pisinemo District Council have approved the FY 2012**
10 **Pisinemo District Budget to be distributed as follows:**

11	Salaries	\$ 679,159.09
12	Fringe Benefits	\$ 205,374.19
13	District Operations	\$ 656,463.51
14	Community Budgets	\$ 120,000.00
15	Total	\$1,660,996.79

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
17 **approve the Pisinemo District FY 2012 District Budget in the amount of \$1,660,996.79.**

18 **BE IT FURTHER RESOLVED that any amendments affecting the funds or funding levels of this**
19 **budget shall be submitted to the Tohono O'odham Legislative Council for further prior**
20 **approval.**


21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28TH Day**
22 **of SEPTEMBER, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
23 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
24 **Section 1 (d)(2) and (3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by**
25 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
27 **18, 1934 (48 Stat. 984).**
