

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Attorney Contract for FY2012 with Steven Weatherspoon PLLC)**

RESOLUTION NO. 11-485

1 WHEREAS, the Office of Attorney General continues to require the legal services of Steven
2 Weatherspoon to assist the Tohono O'odham Nation with respect to matters relating
3 to the Nation's water, including implementation of the Nation's Water Code,
4 implementation of SAWRSA, water settlements, and other related matters as
5 assigned by the Attorney General; and

6 WHEREAS, funding for the attorney contract will be from the SAWRSA Trust Fund, account
7 number 21-2010-810; and


8 WHEREAS, the Domestic Affairs, Water Resources and Budget & Finance Committees have
9 reviewed the attorney contract and recommend approval by the Legislative Council.

10 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:

- 11 1. Approves the Attorney Contract with Steven Weatherspoon, PLLC, in the amount
12 of \$150,000.00 for the period October 1, 2011 to September 30, 2012, substantially
13 in the form attached hereto.
- 14 2. Funding for the Attorney Contract shall be from the SAWRSA trust fund, account
15 number 21-2010-810.
- 16 3. The Chairperson of the Nation is authorized and directed to execute the Attorney
17 Contract.

18 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day
19 of OCTOBER, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-
20 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article
21 VI, Section 2 (a) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
22 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
23 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
24 Stat. 984).


