1	WHEREAS, the Tohono O'odham Nation Department of Public Safety Fire Department has
2	deemed it critical and necessary to increase Fire Protection services to the Tohono
3	O'odham Nation, particularly the Desert Diamond Casino/Hotel; and
4	WHEREAS, the Tohono O'odham Legislative Council by Resolution No. 07-670 approved a reques
5	of \$4,055,700.00 for the construction of a permanent fire/police substation, aeria
6	ladder truck and other related professional services, equipment and training; and
7	WHEREAS, the actual construction of the proposed fire/police substation will not begin until F
8	2012; and
9	WHEREAS, other related needs such as architectural and construction management services
10	training, and supplies remain; and
11	WHEREAS, \$3,056,457.70 was unexpended in the Fire Department Fiscal Year 2011 Capital Budget
12	and
13	WHEREAS, the Domestic Affairs Committee and the Budget and Finance Committee of the
14	Legislative Council have reviewed this budget and recommend its approval and
15	adoption.
16	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves carry
17	forward of unexpended FY 2011 funds in the amount of \$3,056,457.70 into FY 2012 to
18	construct a substation and fund other associated needs in accordance with the budge
19	attached hereto.
20	BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes the
21	Chairman and any designated official to expend and administer the budget as
22	attached, provided that any amendments affecting the funds or funding level shall be
23	submitted for further prior approval by the Tohono O'odham Legislative Council.
