

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Certification of the Tohono O'odham Eligible Minor Members**  
**Listing for the Fourth Per Capita Distribution)**

**RESOLUTION NO. 12-008**

1 **WHEREAS, on June 28, 1997 the Nation's voters approved Initiative No. IN-01-97, the "Tohono**  
2 **O'odham Voice in the Use of Gaming Revenues" (Initiative), which authorizes per**  
3 **capita payments to the Nation's members provided that sufficient gaming revenues**  
4 **are available; and**

5 **WHEREAS, the Ordinance for the Regulation of Gaming Activities within the Tohono O'odham**  
6 **Nation ("Gaming Ordinance") was subsequently amended to authorize per capita**  
7 **distribution payments in accordance with the Initiative (Legislative Council**  
8 **Resolution No. 97-303); and**

9 **WHEREAS, the Fourth Per Capita Revenue Allocation Plan ("Revenue Allocation Plan") which**  
10 **authorizes the fourth per capita payment to all eligible Tohono O'odham members,**  
11 **was adopted by the Tohono O'odham Legislative Council, Resolution No. 09-164; and**

12 **WHEREAS, on June 15, 2009, the Department of the Interior approved the Revenue Allocation**  
13 **Plan; and**

14 **WHEREAS, in accordance with the Revenue Allocation Plan, the Tohono O'odham Membership**  
15 **Services presented the Master List for eligible Tohono O'odham Minor Members for**  
16 **the Fourth Per Capita Distribution and established the number of eligible minor**  
17 **members at 8,664 members pursuant to Resolution No. 09-429; and**

18 **WHEREAS, the Tohono O'odham Legislative Council has established the number of eligible minor**  
19 **members at 8,664 pursuant to Resolution No. 09-429, "Approving the Master List for**  
20 **the Fourth Per Capita Distribution for Eligible Tohono O'odham Minor members; and**

21 **WHEREAS, 55 of the minors approved in Resolution No. 09-429 have since reached the age of 18;**  
22 **and**

23 **WHEREAS, the Enrollment Program submits to the Tohono O'odham Legislative Council a**  
24 **Certification Listing for 55 eligible minor members for the fourth per capita**  
25 **distribution because these 55 minors have reached the age of 18 and are no longer**  
26 **restricted from receiving their per capita payments; and**

27 **WHEREAS, the disbursement of per capita payments to each eligible Tohono O'odham member**  
28 **is contingent upon verification of membership and further certification by the Tohono**  
29 **O'odham Legislative Council.**



1 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
2 **Certification Listing for 55 eligible minor members for the fourth per capita**  
3 **distribution pursuant to the Revenue Allocation Plan.**

4 **BE IT FINALLY RESOLVED** that the Enrollment Program is authorized to disburse the fourth per  
5 **capita payment to these 55 eligible Tohono O'odham members.**

6 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09<sup>TH</sup> Day**  
7 **of JANUARY, 2012 at a meeting at which a quorum was present with a vote of 2,579.90 FOR; -0-**  
8 **AGAINST; -0- NOT VOTING; and 200.70 [03] ABSENT, pursuant to the powers vested in the Council**  
9 **by Article VI, Section 1 (d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**  
10 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
11 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
12 **18, 1934 (48 Stat. 984).**




