RESOLUTION NO. 12-012

1 **WHEREAS, the Tohono O'odham Nation has been awarded Grant No. 2010-TW-AX-0020 from the**
2 **Department of Justice for a three year grant project period 10/01/10-09/30/13 in the**
3 **amount of \$900,000.00 to provide crisis intervention for Tohono O'odham women and**
4 **girls who are victims/survivors of domestic violence, sexual assault and stalking; and**

5 **WHEREAS, the Tohono O'odham Nation-Domestic Violence Program was awarded \$900,000.00**
6 **and is in its second year of implementation for this grant award; and**

7 **WHEREAS, a budget of \$300,000.00 was prepared for Fiscal Year 2012; and approved by**
8 **Resolution #11-336; and**

9 **WHEREAS, a budget amendment has been prepared to correct the position titles of Project**
10 **Manager to Domestic Violence Project Manager and from Program Specialist to**
11 **Victim Advocate; and**

12 **WHEREAS, adjust line item 9000 Indirect Cost Charges from 16.82% to 18.82%, a decrease to line**
13 **item 7665 Client Support to allow to stay within budget amount of \$300,000.00; and**

14 **WHEREAS, the Health and Human Services Committee and the Budget and Finance Committee**
15 **of the Legislative Council have reviewed this budget amendment and recommend its**
16 **approval and adoption.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
18 **and authorizes:**

- 19 **1. Budget Amendment to correct the position titles of the Project Manager to**
20 **Domestic Violence Project Manager and job title Program Specialist to Victim**
21 **Advocate.**
- 22 **2. Adjust line item 7665 Client Support to the amount of \$15,342.54 due to the**
23 **increase of line item 9000 Indirect Cost Charges.**

24 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
25 **Chairperson and any designated official to expend and administer the budget as**
26 **attached, provided that any amendments affecting the funds or funding level is**
27 **submitted for further prior approval by the Tohono O'odham Legislative Council.**


