

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving New award for the Family Violence Prevention and Services Grant from
the U.S. Department of Human Services Administration for Children and Families
FY 2012 Amendment No. 1, Account #300.12.6295)

RESOLUTION NO. 12-013

1 **WHEREAS, prevention of injuries is priority for the Tohono O'odham Nation; and**

2 **WHEREAS, the Domestic Violence Program within the Department of Health and Human**
3 **Services Community Health Division, and the Domestic Violence Coalition are**
4 **working to raise awareness of family violence and continue the development of**
5 **services for domestic violence victims and their families; and**

6 **WHEREAS, the Family Violence Prevention and Services Grant award letter has been received**
7 **and indicates the new award amount to be \$123,892.00, a decrease of \$12,668.00 from**
8 **the estimated amount of \$136,560.00; and**

9 **WHEREAS, the Family Resource Specialist position is not filled and will be eliminated to allow**
10 **for more in operating cost in this budget amendment. The Family Resource Specialist**
11 **Position was filled on a temporary basis and not filled permanently. The elimination**
12 **of the position will have no negative impact in the Family Violence Program. The**
13 **increase in the operating cost would be very beneficial as the awareness of Family**
14 **Violence Prevention has increased therefore increasing the need to provide more**
15 **service and support; and**

16 **WHEREAS, Eliminating the Family Resource Specialist position will result in a total decrease of**
17 **\$41,991.49 from line items 6000 Salaries and 6200 Fringe; therefore allowing the**
18 **following modifications to program line items; and**

19 **WHEREAS, a total increase in the amount of \$33,990.42 made to line items 6500 Tuition and**
20 **Registration, 7300 Advertisement, 7000 Supplies-Office, 7005 Supplies-Other, 7010**
21 **Program Supplies, 7355 Professional Services, 7340 Public Relations, 7060 Food, 7665**
22 **Client Support, and a total decrease of \$1,787.00 made to line items 6530 Travel**
23 **Expense, 7110 Communications, and 9000 Indirect Cost Charges adjusts the total**
24 **amount of the budget to \$123,892.00 for Fiscal Year 2012; and**

25 **WHEREAS, the Health and Human Services Committee and the Budget and Finance Committee**
26 **of the Legislative Council have reviewed this Budget and recommend its approval and**
27 **adoption.**



4 **Grant.**

5 **BE IT FINALLY RESOLVED** that the Tohono O'odham Legislative Council hereby authorizes the
6 **Chairperson and any designated official to expend and administer the budget as**
7 **attached, provided that any amendments affecting the funds or funding level is**
8 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

9 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH Day**
10 **of JANUARY, 2012 a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
11 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
12 **Section 1 (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
13 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
14 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
15 **Stat. 984).**


