

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Authorizing the U.S. Department of Interior Office of Special Trustee to Distribute**  
**the Tohono O'odham Nation's Funds from Judgment Account Held at the U.S.**  
**Department of Interior Office of Special Trustee)**

RESOLUTION NO. 12-017

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Tohono O'odham Legislative**  
2 **Council with legislative and fiscal powers, including the power "to manage any funds**  
3 **within the exclusive control of the Tohono O'odham Nation, including proceeds**  
4 **derived from lands and resources of the Tohono O'odham Nation" (Constitution,**  
5 **Article VI, Section 1(d)(2)); and**

6 **WHEREAS, pursuant to U.S. Public Law 97-408, Section 8(b)(1), the U.S. Department of Interior**  
7 **Office of Special Trustee reported available funds for distribution in the amount of**  
8 **\$4,748,457.70 in the Judgment Account ending 6215 as of December 12, 2011; and**

9 **WHEREAS, the Tohono O'odham Nation ("Nation") has a need to use these funds in its FY2012**  
10 **operating budget adopted by Tohono O'odham Legislative Council Resolutions No.**  
11 **11-320, 11-321, and 11-322; and**

12 **WHEREAS, the U.S. Department of Interior Office of Special Trustee and the Nation's Treasurer**  
13 **reported on the available funds to the Nation's Investment Committee on November**  
14 **28, 2011 and the Investment Committee supports drawing down of these funds at this**  
15 **time; and**

16 **WHEREAS, the Nation's Treasurer recommends that these funds be drawn down into the Nation's**  
17 **General Checking Account at Bank of America.**

18 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
19 **authorizes the U.S. Department of Interior Office of Special Trustee to distribute the**  
20 **Tohono O'odham Nation's funds, pursuant to U.S. Public Law 97-408, Section 8(b)(1),**  
21 **from the Judgment Account held at the U.S. Department of Interior Office of Special**  
22 **Trustee in the following amount:**

24 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council authorizes the release**  
25 **of the applicable wire instructions for the Nation's General Checking Account at Bank**  
26 **of America to the U.S. Department of Interior Office of Special Trustee to facilitate the**  
27 **distribution of the funds.**



3 **Nation's FY2012 Budget.**

5 **of JANUARY, 2012 a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**  
6 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**  
7 **Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the**  
8 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
9 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
10 **18, 1934 (48 Stat. 984).**
