

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Gu Achi District's Chairperson to initiate fund transfers on**  
**behalf of the Gu Achi District from the Office of the Special Trustee**  
**(OST) to the Gu Achi District's Investment Account for the Fiscal**  
**Year Starting October 1, 2011 and ending September 20, 2012)**

RESOLUTION NO. 12-024

1 **WHEREAS, the Tohono O'odham Legislative Council did convene on January 11, 2012 to address**  
2 **issues pertaining to the Nation; and**

3 **WHEREAS, on December 2, 2011, the Gu Achi District Council did pass Resolution #1112-121 to**  
4 **have the District Chairperson to initiate funds to be transferred on behalf of the**  
5 **District from the Office of the Special Trustee (OST) to the District's investment**  
6 **account; and**

7 **WHEREAS, the funds are being held by the Bureau of Indian Affairs (BIA) and the OST (IN**  
8 **#PL7536706); and**

9 **WHEREAS, the Gu Achi District has been approached by the Fiduciary Trust Officer from the OST**  
10 **Papago Office in Sells, regarding immediate transfer of funds to the Gu Achi District;**  
11 **and**

12 **WHEREAS, the Gu Achi District prefers that these funds be electronically transferred to their**  
13 **Investment Account at Wells Fargo; and**

14 **WHEREAS, the Gu Achi District Chairperson and the District Treasurer are the primary contacts**  
15 **that would be responsible for communications with the OST and the initiation of the**  
16 **electronic transfers; and**

17 **WHEREAS, the Gu Achi District Council, after the balance has been disbursed, requests closure**  
18 **of account #PL7536706.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
20 **authorizes the Office of Special Trustee and the Bureau of Indian Affairs to initiate the**  
21 **disbursement to the Gu Achi District of the balance of account #PL7536706 and closure**  
22 **of said account.**

23 **BE IT FINALLY RESOLVED that these funds will be wired directly to the Gu Achi District's Wells**  
24 **Fargo Investment Account.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11<sup>TH</sup> Day**  
26 **of JANUARY, 2012 a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**  
27 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
28 **Section 1(d)(2) and (3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by**  
29 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
31 **18, 1934 (48 Stat. 984).**




