

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Gu Achi District Budget from the Fiscal Year 2012 Apportionment**  
**of Mining Royalties in the amount of \$130,769.60)**

RESOLUTION NO. 12-025

1 **WHEREAS, the Tohono O'odham Legislative Council did convene on January 11, 2012 to address**  
2 **issues pertaining to the Nation; and**

3 **WHEREAS, the Tohono O'odham Legislative Council passed Resolution #11-486 "Approving FY**  
4 **2012 Apportionment of Mining Royalties by Equal Distribution" for a distribution**  
5 **formula of \$1,371,336.58 to the eleven political Districts for an equal distribution**  
6 **amount of \$124,666.96; and**

7 **WHEREAS, the equal distribution amount of the \$124,666.96 to the eleven Districts also included**  
8 **interest earned on prior balances (\$6,102.64 for Gu Achi District) totaling to the**  
9 **amount of \$130,769.60; and**

10 **WHEREAS, on November 19, 2011, the Gu Achi District Council approved a budget in the amount**  
11 **of \$130,769.60 to include budget line items to fund the expense of conducting a**  
12 **financial audit for the Gu Achi Trading Post in the amount of \$30,769.60 (Line Item**  
13 **#803) and for the purpose of investments received by the District in the amount of**  
14 **\$100,000.00 (Line Item #901).**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
16 **approve the Gu Achi District Budget from the Fiscal Year 2012 Apportionment of**  
17 **Mining Royalties in the amount of \$130,769.60 as attached hereto.**

18 **BE IT FINALLY RESOLVED that the Gu Achi District Council has the authority to modify its Fiscal**  
19 **Year 2012 Mining Royalties budget in accordance with protocols set forth by this**  
20 **Council. Any amendments affecting the funds or funding levels of the Gu Achi**  
21 **District's Fiscal Year 2012 Mining Royalties budget shall be approved by the Tohono**  
22 **O'odham Legislative Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11<sup>TH</sup> Day**  
24 **of JANUARY, 2012 a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**  
25 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
26 **Section 1 (d)(2) and (3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by**  
27 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
29 **18, 1934 (48 Stat. 984).**






