

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of Budget Modification #1 of Account No. 100-12-5001 to Reflect a Cash Match of \$166,667.00 for the FY2010 Emergency Operations Center Grant Program, Grant #2010-EO-MX-0013)

RESOLUTION NO. 12-028

1 **WHEREAS, the United States Department of Homeland Security, Federal Emergency**
2 **Management Agency has distributed grants to tribes, states and counties, to fund**
3 **construction projects, equipment purchases, training and personnel costs by**
4 **departments that provide emergency management services within their respective**
5 **jurisdictions; and**

6 **WHEREAS, the Tohono O'odham Nation Department of Public Safety has received a grant award**
7 **of the FY2010 Emergency Operations Center (EOC) Grant Program in the amount of**
8 **\$500,000.00, which requires a twenty-five percent (25%) match; and**

9 **WHEREAS, the Tohono O'odham Nation Police Department requires changes to its FY2012**
10 **Budget Account 100-12-5001 in order to reflect the twenty-five percent cash match in**
11 **the amount of \$166,667.00; and**

12 **WHEREAS, the FY2010 EOC Grant Program award of \$500,000.00 has been accepted by resolution**
13 **of the Tohono O'odham Legislative Council; and**

14 **WHEREAS, the FY2012 Budget Account 100-12-5001 was appropriately changed to reflect no**
15 **monetary funding level changes but only changes within the appropriate Budget**
16 **Narrative to reflect the twenty-five percent (25%) cost share match for the grant; and**

17 **WHEREAS, the Modification #1 of the Police Department's FY2012 Budget Account #100-12-5001**
18 **has been reviewed by the Budget Office, Executive Office, Domestic Affairs Committee**
19 **and Budget & Finance Committee, of which all recommend acceptance of the budget**
20 **amendment by the Legislative Council.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and**
22 **accepts the Budget Modification #1 of the Tohono O'odham Nation Police Department**
23 **FY2012 Budget Account # 100-12-5001 to reflect no monetary change in the funding**
24 **level and reflect the twenty-five percent (25%) cost share match within the Budget**
25 **Narrative of the appropriate line item for the FY2010 EOC Grant Program award.**

26 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
27 **Chairperson and any designated official to expend and administer the budget as**
28 **attached, provided that any modifications affecting the funds or funding level shall**
29 **be submitted for further prior approval by the Tohono O'odham Legislative Council.**
