

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Chukut Kuk District FY2012 Budget Amendment No. 1)**

RESOLUTION NO. 12-034

1 **WHEREAS, the Chukut Kuk District Council did meet on November 22, 2011 in San Miguel at which**  
2 **a quorum was present; and**

3 **WHEREAS, the Chukut Kuk District Council did receive the FY2012 apportionment of Mining**  
4 **Royalties in the amount of \$134,103.41 and by Resolution No. 2011-87 approved to add**  
5 **into the FY2012 Administration budget; and**

6 **WHEREAS, FY2012 Budget Amendment No. 1 was presented to the Legislative Council Budget &**  
7 **Finance Committee for review.**

8 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
9 **Chukut Kuk District FY2012 Budget Amendment No. 1 attached hereto and**  
10 **incorporated herein increasing the FY2012 budget from \$1,660,996.79 to**  
11 **\$1,795,100.20.**

12 **BE IT FURTHER RESOLVED that the FY2012 Chukut Kuk District apportionment of Mining**  
13 **Royalties in the amount of \$134,103.41 will be added to various line items in the**  
14 **FY2012 Administration budget to cover expenditure of funds and anticipated costs.**

24 **Legislative Council for prior approval.**

26 **of JANUARY, 2012 a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**  
27 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
28 **Section 1 (d)(2) and (3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by**  
29 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
31 **18, 1934 (48 Stat. 984).**
