

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Accepting and Approving FY 2012 First Things First Early Childhood/Head Start Budget)**

RESOLUTION NO. 12-045

1 **WHEREAS, the First Things First Tohono O'odham Nation Regional Council has awarded funds to**
2 **the Tohono O'odham Nation for the Early Childhood/Head Start Program; and**

3 **WHEREAS, the Tohono O'odham Nation has operated and continues to operate a Head Start**
4 **Program to provide educational, health, mental health, and parent involvement**
5 **services to children, three to five years of age; and**

6 **WHEREAS, the First Things First Tohono O'odham Nation Regional Council has awarded the**
7 **Tohono O'odham Nation an amount of \$125,000.00; and**


8 **WHEREAS, the Human Resources Development Committee and the Budget and Finance**
9 **Committee of the Tohono O'odham Nation Legislative Council have reviewed the**
10 **budget and recommend its approval and adoption.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
12 **the FY 2012 Budget in the amount of \$125,000.00, as attached, to the Executive Branch**
13 **to be effective July 1, 2011 through June 30, 2012 and request authorization to expend**
14 **funds and to utilize the Nation's resources pending reimbursement from the grantor**
15 **for the continuation of the grant.**

16 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
17 **Chairperson and any designated official to expend and administer the budget as**
18 **attached, provided that any amendments affecting the funds or funding level is**
19 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH Day**
21 **of FEBRUARY, 2012 a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
22 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
23 **Section 1 (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
24 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
25 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
26 **Stat. 984).**
