7	Tohono O'odham Nation an amount of \$125,000.00; and
8	WHEREAS, the Human Resources Development Committee and the Budget and Finance
9	Committee of the Tohono O'odham Nation Legislative Council have reviewed the
10	budget and recommend its approval and adoption.
11	${\bf NOW, THEREFORE, BEITRESOLVEDthattheTohonoO'odhamLegislativeCouncilherebyapproves}$
12	the FY 2012 Budget in the amount of \$125,000.00, as attached, to the Executive Branch
13	to be effective July 1, 2011 through June 30, 2012 and request authorization to expend
14	funds and to utilize the Nation's resources pending reimbursement from the grantor
15	for the continuation of the grant.
16	BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
17	Chairperson and any designated official to expend and administer the budget as
18	attached, provided that any amendments affecting the funds or funding level is
19	submitted for further prior approval by the Tohono O'odham Legislative Council.
