5	an area near San Simon community on Highway 86 mile post 76.5 also known as the
6	old A.D.O.T. Station; and
7	WHEREAS, a majority of the funds will go toward renovations and additions to an existing
8	building located on site and currently owned by the Pisinemo District; and
9	WHEREAS, the FY 2012 Mining Royalty budget proposal is in the amount of \$131,538.69, which
10	\$60,000.00 is budgeted for Repair & Maintenance Building, and \$71,538.69 towards
11	Professional Services.
12	NOW, THEREFORE, BE IT RESOLVED the Tohono O'odham Legislative Council approves the
13	Pisinemo District FY 2012 Mining Royalty Budget in the amount of \$131,538.69.
14	BE IT FURTHER RESOLVED that the Tohono O'odham Legislative/District Council hereby
15	authorizes the District Chairperson and any designated official to expend and
16	administer the budget as attached, provided that any amendments affecting the funds
17	or funding level shall be submitted for further prior approval by the Tohono O'odham
18	Legislative/District Council.
