

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Santa Cruz Community Budget Modification/Amendment No. 1 in the amount of \$2,500.00 and adding additional language to its Supplies Kitchen line item)**

RESOLUTION NO. 12-051

1 **WHEREAS, the Tohono O'odham Legislative Council at a regularly scheduled meeting reviewed**
2 **a proposal from Santa Cruz Community to modify and amend its FY 2012 Community**
3 **Budget to add additional language to its budget justification; and**

4 **WHEREAS, the community approved to include additional wording to its Supplies Kitchen line**
5 **item to read (To purchase a double oven stove, 3 compartment sink with accessories,**
6 **work tables, fire extinguishers, upright freezer, utility carts, tables, chairs, paper**
7 **ware, microwave, and refrigerator for the community feast house); and**

8 **WHEREAS, \$1,000.00 was deducted from Line Item #721 (Supplies-Other) and \$1,500.00 from Line**
9 **Item #727 (Materials), and adding \$2,500.00 to Line Item #724 (Supplies-Kitchen).**

10 **NOW, THEREFORE, BE IT RESOLVED the Tohono O'odham Legislative Council approves the Santa**
11 **Cruz Community Budget Modification/Amendment No. 1 in the amount of \$2,500.00**
12 **and adding additional language to its Supplies Kitchen line item.**

13 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative/District Council hereby**
14 **authorizes the District Chairperson and any designated official to expend and**
15 **administer the budget as attached, provided that any amendments affecting the funds**
16 **or funding level shall be submitted for further prior approval by the Tohono O'odham**
17 **Legislative/District Council.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH Day**
19 **of FEBRUARY, 2012 a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
20 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
21 **Section 1 (d)(2) and (3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by**
22 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
24 **18, 1934 (48 Stat. 984).**




