

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Budget Amendment No. 1 to increase FY2012 Economic Development Budget)**

RESOLUTION NO. 12-055

1 **WHEREAS, the Legislative Council is authorized "to manage any funds within the exclusive**
2 **control of the Tohono O'odham Nation ... and to appropriate these funds for the**
3 **benefit of the nation and its members" provided that "(a)ll expenditures of these funds**
4 **shall be pursuant to appropriations or budgets" authorized by resolution or**
5 **ordinance (Constitution of the Tohono O'odham Nation, Article VI, Section 1(d)(2)); and**

6 **WHEREAS, the Legislative Council appointed a delegation ("Nation's Delegation") to explore**
7 **economic development projects; and**

8 **WHEREAS, by Resolution No. 11-320, the Legislative Council passed an Economic Development**
9 **Budget as part of the Executive Branch Fiscal Year 2012 Tribal Budget; and**

10 **WHEREAS, the Legislative Council has been briefed on additional actions that are necessary to**
11 **promote economic development and has developed Amendment No. 1 to the Economic**
12 **Development Budget for that purpose; and**

13 **WHEREAS, the Nation's Chairman is authorized to administer the Economic Development Budget**
14 **in consultation with the other members of the Nation's Delegation; and**

15 **WHEREAS, Budget and Finance Committee of the Legislative Council has reviewed Budget**
16 **Amendment No. 1 and recommends its approval and adoption.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
18 **appropriates \$2,600,000.00 from the General Fund Surplus for Amendment No. 1 to the**
19 **Economic Development Budget for one time funding.**

20 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
21 **Chairperson and any designated official to expend and administer the budget as**
22 **attached, provided that any amendments affecting the funds or funding level is**
23 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17TH Day**
25 **of FEBRUARY, 2012 a meeting at which a quorum was present with a vote of 2,438.60 FOR; -0-**
26 **AGAINST; [03] NOT VOTING; and 342.0[05] ABSENT, pursuant to the powers vested in the Council**
27 **by Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the**
28 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
30 **18, 1934 (48 Stat. 984).**


