

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval and Acceptance of the U.S. Department of Transportation 5311 Transit
Grant for FY 2012 for a Tribal Transit Program)

RESOLUTION NO. 12-056

1 **WHEREAS, the United States Department of Transportation has distributed grants to tribes to**
2 **fund Tribal Transit Programs; and**

3 **WHEREAS, Indian tribes have been designated to receive funds, requiring tribes to approve a**
4 **resolution; and**

5 **WHEREAS, the Tohono O'odham Nation was approved as a grant recipient on December 13, 2010;**
6 **and**

7 **WHEREAS, the Legislative Council passed Resolution Number 99-059, which details the procedure**
8 **for Executive Branch Departments to apply for grants; and**

9 **WHEREAS, the 5311 grant will fund \$389,693.00 for the Tohono O'odham Tribal Transit Program**
10 **for the period of 12 months, beginning approximately April 2012 and ending in April**
11 **2013 or until funds are expended; and**

12 **WHEREAS, the Planning Department has prepared a budget in the amount of \$389,693.00 for**
13 **FY2012; and**

14 **WHEREAS, the Planning Department has met with the Commerce and Budget & Finance**
15 **Committees to review the 5311 grant and the Commerce and Budget & Finance**
16 **Committees recommend approval by the Tohono O'odham Legislative Council; and**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby accepts,**
18 **approves, and authorizes the US Department of Transportation 5311 Grant in the**
19 **amount of \$389,693.00 for the period of twelve months.**

20 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council authorizes the Planning**
21 **Department to expend funds from the attached budget hereto in the amount of**
22 **\$389,693.00 for FY2012 with any unexpended funds to roll over into FY2013.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
24 **Nation's officials to wit: the Chairman, Vice-Chairwoman, and any designated official**
25 **are authorized to negotiate, execute, and submit all required documents for the US**
26 **Department of Transportation 5311 Grant, including the Annual Assurances and**
27 **Certifications, provided that any amendments affecting the funds or funding level of**
28 **this grant shall be submitted for further prior approval by the Tohono O'odham**
29 **Legislative Council.**




