

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Setting February 29, 2012 Special Session to Address the Trust Mismanagement  
Settlement Proposal)**

**LEGISLATIVE ORDER NO. 12-058**

1 **WHEREAS, the Legislative Council is vested with the power "to establish rules and procedures to**  
2 **regulate all meetings of the Tohono O'odham Council, standing committees, boards**  
3 **and special committees." (Constitution of the Tohono O'odham Nation, Article VI,**  
4 **Section 1(a)); and**  
5 **WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council vests the Council with**  
6 **the authority to "by majority vote, call for a special session" (Legislative Rules of the**  
7 **Tohono O'odham Legislative Council, Article I, Section 1.D.1.); and**  
8 **WHEREAS, the Trust Settlement Delegation has requested a special session on February 29, 2012**  
9 **to address the trust mismanagement settlement proposal.**  
10 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it sets a**  
11 **special session for February 29, 2012 to address the trust mismanagement settlement**  
12 **proposal.**

13 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 24<sup>TH</sup> day of**  
14 **FEBRUARY, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**  
15 **AGAINST; -0- NOT VOTING; and 02 ABSENT, pursuant to the powers vested in the Council by Article**  
16 **VI, Section 1(a) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
17 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
18 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
19 **Stat. 984).**
