LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL

(Authorizing Execution of Accurate Background, Inc. "End User Agreement")

LEGISLATIVE ORDER NO. 12-063

Ţ	WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with the
2	power to "negotiate and conclude agreements and contracts on behalf of the Tohono
3	O'odham Nationwith private persons or organizations on all matters within the
4	authority of the Tohono O'odham Council" (Constitution, Article VI, Section 1(f)); and
5	WHEREAS, the Council has prescribed the duties and powers of the Council Chairman and Vice
6	Chairman (collectively, "legislative officers") by adopting the Legislative Rules and by
7	passing Legislative Order No. 06-047, "Amended Delegation of Authority to Legislative
8	Council Chairperson and Vice Chairperson"; and
9	WHEREAS, although Legislative Order No. 06-047 expressly delegates to the legislative officers the
10	authority to negotiate, execute, and administer certain contracts, the officers are not
11	authorized to enter contracts that "indemnify a third party or authorize payment of
12	an award of attorney fees or costs of litigation or arbitration, unless previously
13	authorized by a majority vote of the Legislative Council"; and
14	WHEREAS, at the request of legislative committees, the legislative officers have searched for and
15	selected Accurate Background, Inc. to provide background investigation services to
16	the Legislative Branch; and
17	WHEREAS, the Accurate Background, Inc. "End User Agreement" does not expressly require the
18	Legislative Branch to waive its sovereign immunity but does include an
19	indemnification clause and other provisions which require Legislative Council
20	approval.
21	${f NOW}, {f THEREFORE}, {f BE}$ IT ORDERED by the Tohono O'odham Legislative Council that it authorizes
22	the legislative officers to enter into the Accurate Background, Inc. "End User
23	Agreement," which shall be funded by the Legislative Branch Professional Services line
24	item 001-12-9000-7355, provided that nothing in this delegation or in the agreement
25	shall be deemed a waiver of the Nation's sovereign immunity or legislative immunity.
26 27 28 29 30 31 32	The foregoing Order was passed by the Tohono O'odham Legislative Council on the 29 TH day of FEBRUARY, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-AGAINST; -0-NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary-Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
