

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Legislative Rules of the Tohono O'odham Legislative Council)**

**DEFEATED
RESOLUTION NO. 12-072**

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Tohono O'odham Legislative**
2 **Council with the power to establish rules and procedures to regulate all meetings of**
3 **the Council and its standing committees (Constitution of the Tohono O'odham Nation,**
4 **Article VI, Section 1(a)); and**

5 **WHEREAS, the Legislative Council has exercised this power by adopting and amending the**
6 **Legislative Rules of the Tohono O'odham Legislative Council ("Legislative Rules")**
7 **(Legislative Orders No. 06-460, No. 06-635, No. 09-188, No. 09-574, No. 11-179 and**
8 **11-306); and**

9 **WHEREAS, it is in the Legislative Council's best interest to amend Legislative Rules Article III,**
10 **Section 4; Article VIII, Section 1(A)(1); and Article IX, Section 1(A) in accordance with**
11 **the attached Legislative Rules amendments as dated for reference February 2012 in**
12 **order to more accurately describe the transmission of required documents to the**
13 **Secretary and Secretary's review of legislative actions that are adopted by the**
14 **Legislative Council.**

15 **NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council hereby adopts**
16 **the Legislative Rules amendments as dated for reference February 2012, which shall**
17 **be effective March 19, 2012.**

18 **The foregoing Resolution was defeated by the Tohono O'odham Legislative Council on the 12TH Day**
19 **of MARCH, 2012 at a meeting at which a quorum was present with a vote of 1,033.85 FOR; 1,746.75**
20 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article**
21 **VI, Section 1(a) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
22 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
23 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
24 **Stat. 984).**
