

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the North Communities Fiscal Year 2012 Budget Amendment No. 1)**

RESOLUTION NO. 12-074

1 **WHEREAS, North Communities Resolution No. NC-139-11; Sells District Council Resolution No. SD-**
2 **97-11; and Tohono O'odham Legislative Council Resolution No. 11-455 approved the**
3 **FY2011 Budgets for the Sells District and its Communities; and**

4 **WHEREAS, North Communities have identified the necessity to amend their budget to address the**
5 **needs of its members by increasing Line items 750-Capital by \$40,000.00; 861-**
6 **Miscellaneous Assistance by \$8,000.00; 865-Emergency Assistance by \$4,000.00; and**

7 **WHEREAS, the increases will decrease Line Items 612-Occasional Appointments by (\$10,000.00);**
8 **727-Building Materials by (\$40,000.00); 772-Repair & Maintenance of Building by**
9 **(\$2,000.00); and**

10 **WHEREAS, changes were also made to the original justifications to line items Occasional**
11 **Appointments, Building Materials, Capital, Repair & Maintenance of Building,**
12 **Miscellaneous, Emergency; and**

13 **WHEREAS, the attached budget Amendment No.1 and its justifications have been reviewed and**
14 **approved by the North Communities with Resolution No. NC-59-12 and by the Sells**
15 **District Council with Resolution No. SD-08-12.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
17 **North Communities Fiscal Year 2012 Budget Amendment No. 1 of Gaming Revenues by**
18 **increasing Line items 750-Capital by \$40,000.00; 861-Miscellaneous Assistance by**
19 **\$8,000.00; 865-Emergency Assistance by \$4,000.00 which will decrease Line Items 612-**
20 **Occasional Appointments by (\$10,000.00); 727-Building Materials by (\$40,000.00); 772-**
21 **Repair & Maintenance of Building by (\$2,000.00).**

22 **BE IT FURTHER RESOLVED that changes were made in the justification and to amounts in the**
23 **justification to reflect the new budgeted amounts and this does not affect the Sells**
24 **District Fiscal Year 2012 budgeted amount of Gaming Revenues for the North**
25 **Communities budget.**

26 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the Sells**
27 **District Chairperson and any designated official to expend and administer the budget,**
28 **as attached, provided that any modifications/amendments affecting the funds or**
29 **funding levels of the budget shall be submitted for further prior approval by the**
30 **Tohono O'odham Legislative Council.**

7 Stat. 984).




