10	of \$136,514.33 which has been reviewed by the Budget Office, Grants & Contracts,
11	Executive Office, Domestic Affairs Committee and Budget & Finance Committee, of all
12	which recommend acceptance by the Tohono O'odham Legislative Council.
13	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby
14	approves the FY 2012 Department of Justice Office of Justice Programs Project Safe
15	Neighborhood Indian Country Pilot Program carryover budget in the amount of
16	\$136,514.33 to include Personnel Cost of \$93,366.87 with no Indirect Cost.
