1 **WHEREAS, the Tohono O'odham Nation Police Department (TONPD) was awarded and accepted**  
2 **the Department of Justice Office of Justice Program Project Safe Neighborhood Indian**  
3 **Country Pilot Program Grant No. 2009-GP-BX-0096 through TOLC Resolution No. 09-**  
4 **553 and 10-474; and**

5 **WHEREAS, the grant is effective August 1, 2009 through July 31, 2012; and**

6 **WHEREAS, the TONPD has prepared an FY 2012 budget with the carry over funds in the amount**  
7 **of \$136,514.33 to include Personnel Cost; Operational Cost of \$93,366.87; and**

8 **WHEREAS, this grant does not allow for Indirect Cost; and**


9 **WHEREAS, the Tohono O'odham Nation Police Department has prepared a budget in the amount**  
10 **of \$136,514.33 which has been reviewed by the Budget Office, Grants & Contracts,**  
11 **Executive Office, Domestic Affairs Committee and Budget & Finance Committee, of all**  
12 **which recommend acceptance by the Tohono O'odham Legislative Council.**

13 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
14 **approves the FY 2012 Department of Justice Office of Justice Programs Project Safe**  
15 **Neighborhood Indian Country Pilot Program carryover budget in the amount of**  
16 **\$136,514.33 to include Personnel Cost of \$93,366.87 with no Indirect Cost.**

17 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes the**  
18 **Chairman and any designated official to expend and administer the budget as**  
19 **attached, provided that any amendments affecting the funds or funding level shall be**  
20 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup> Day**  
22 **of MARCH, 2012 a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**  
23 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Section**  
24 **1(f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
25 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
26 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
27 **Stat. 984).**
