

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Memorandum of Understanding (MOU) between the City of Tucson
(Police Department) and the Nation)**

RESOLUTION NO. 12-078

1 **WHEREAS, the Tohono O'odham Nation Police Department has negotiated a Memorandum of**
2 **Understanding with the City of Tucson (Police Department) to enhance Public Safety**
3 **by sharing law enforcement information owned by each party through the COPLINK**
4 **system; and**

5 **WHEREAS, pursuant to the MOU, the City of Tucson (Police Department) at no cost to the Nation**
6 **will allow the Tohono O'odham Nation Police Department to access their police**
7 **records and information via a secure method of connection to the COPLINK system;**
8 **and**


9 **WHEREAS, the Tohono O'odham Nation Police Department will retain control the flow of any**
10 **sensitive information owned by the Nation; and**

11 **WHEREAS, either party may terminate the MOU upon (30) days prior written notice to the other**
12 **party of its intent to terminate access to its law enforcement information; and**

13 **WHEREAS, the attached MOU has been reviewed by the Domestic Affairs Committee which**
14 **recommends Legislative Council approval.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
16 **the MOU with the City of Tucson (Police Department), substantially in the form**
17 **attached hereto, and authorizes the Chairman of the Nation to execute it.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH Day**
19 **of MARCH, 2012 a meeting at which a quorum was present with a vote of 2,220.0 FOR; 560.60**
20 **AGAINST; [01] NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by**
21 **Section 1 (f) & (l) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the**
22 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
24 **18, 1934 (48 Stat. 984).**


