

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Adopting Amendments to the Amended Judicial Appointment Procedure)**

**DEFEATED
RESOLUTION NO. 12-079**

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Tohono O'odham Legislative**
2 **Council with the power to establish rules and procedures to regulate all meetings of**
3 **the Council and its standing committees (Constitution of the Tohono O'odham Nation,**
4 **Article VI, Section 1(a)); and**

5 **WHEREAS, the Legislative Council is further vested with the power to appoint judges to the**
6 **Tohono O'odham Judicial Court pursuant to Article VIII, Section 3 of the Constitution**
7 **of the Tohono O'odham Nation; and**

8 **WHEREAS, pursuant to Legislative Order No. 03-204, the Legislative Council adopted the**
9 **Amended Judicial Appointment Procedure governing the process for appointing**
10 **Tohono O'odham Judicial Court judges; and**


11 **WHEREAS, the Judiciary Committee recommends the adoption of the attached "Amended Judicial**
12 **Appointment Procedure," which is dated March 2012 and hereby incorporated by this**
13 **reference, to further clarify the appointment process; and**

14 **WHEREAS, the Legislative Council has reviewed the attached "Amended Judicial Appointment**
15 **Procedure," dated for reference March 2012.**

16 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it hereby**
17 **adopts the "Amended Judicial Appointment Procedure" dated for reference March**
18 **2012, which shall become effective immediately and shall govern the Legislative**
19 **Council's process for appointing judges to the Tohono O'odham Judicial Court.**

20 **The foregoing Resolution was defeated by the Tohono O'odham Legislative Council on the 13TH Day**
21 **of MARCH, 2012 at a meeting at which a quorum was present with a vote of 1,053.55 FOR; 1,727.05**
22 **AGAINST; 0 NOT VOTING; and 04 ABSENT, pursuant to the powers vested in the Council by Article**
23 **VI, Section 1(a) and Article VIII, Section 3 of the Constitution of the Tohono O'odham Nation,**
24 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
25 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act**
26 **of June 18, 1934 (48 Stat. 984).**


