

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Accepting and Approving Additional funding for the Cooperative Agreement L08AC14165
between the Tohono O'odham Nation and US Bureau of Land Management and to expend
a \$108,000.00 award for the Solid Waste Management Program FY 2012 budget)**

RESOLUTION NO. 12-080

1 **WHEREAS, the Tohono O'odham Nation received from the US Bureau of Land Management**
2 **Cooperative Agreement #L08AC14165 to fund undocumented migrant trash clean-up**
3 **through December 30, 2012 as stated in the Cooperative Agreement; and**

4 **WHEREAS, this is Cooperative Agreement amendment #0004 and #0005 to contract L08AC14165**
5 **(formerly #AAA080021) between the Tohono O'odham Nation and the US Bureau of**
6 **Land Management provides an additional award of \$75,000.00 and \$33,000.00 to the**
7 **Solid Waste Management Program to expend by September 30, 2012; and**

8 **WHEREAS, the Solid Waste Management Program FY2012 BLM Budget has been reviewed by the**
9 **Agriculture and Natural Resources and the Budget and Finance Committees of the**
10 **Legislative Council and recommend its approval and adoption.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council accepts and**
12 **approves:**

13 **1. The cooperative agreement amendment #0004 and #0005 to the contract**
14 **L08AC14165 (formerly #AAA080021) between the Tohono O'odham Nation and the**
15 **U.S. Bureau of Land Management.**

16 **2. The expenditure of an award of \$108,000.00 from the Bureau of Land Management**
17 **for the Solid Waste Management Program FY 2012 budget, to be expended by**
18 **September 30, 2012 in accordance with the budget attached hereto.**

19 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes the**
20 **Chairperson and any designated official to execute the agreements, expend and**
21 **administer the budget as attached, provided that any amendments affecting the funds**
22 **or funding level is submitted for further prior approval by the Tohono O'odham**
23 **Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH Day**
25 **of MARCH, 2012 a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**
26 **-0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1**
27 **(d)(2)(3) and 1(f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the**
28 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
30 **18, 1934 (48 Stat. 984).**


