1 **WHEREAS, the Sif-Oidak District Council passed Resolution No. SODC-10-193, "Approving the Sif-**
2 **Oidak District FY 2006 Carryover Budget in the amount of \$643,948.00"; and**

3 **WHEREAS, the Tohono O'odham Legislative Council enacted Resolution No. 10-486, "Approving**
4 **the Sif-Oidak District FY 2006 Carryover Budget in the amount of \$643,948.00"; and**

5 **WHEREAS, the majority of the carryover budget has not been expended due to insufficient time**
6 **for the Communities to plan, research and propose projects for their respective**
7 **Communities; and**

8 **WHEREAS, the Sif-Oidak District Council passed Resolution No. SODC-11-200, "Approving the FY**
9 **2006 Carryover Budget in the amount of \$436,564.45 to FY 2012"; and**

10 **WHEREAS, the Tohono O'odham Legislative Budget and Finance Committee did review the budget**
11 **on February 27, 2012 and recommends approval.**


12 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does hereby**
13 **approve the Sif-Oidak District FY 2006 carryover budget in the amount of \$436,564.45**
14 **to FY 2012.**

15 **BE IT FURTHER RESOLVED that this Budget will become effective immediately upon approval.**

16 **BE IT FINALLY RESOLVED that any amendments affecting the funding or funding levels of the**
17 **attached budget shall be submitted for further prior approval by the Tohono O'odham**
18 **Legislative Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH Day**
20 **of MARCH, 2012 a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**
21 **-0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)**
22 **and (3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
23 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
25 **Stat. 984).**


