

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Enrollment or Adoption Applications for Membership in the Tohono  
O'odham Nation for March 2012)**

**RESOLUTION NO. 12-085**

1 **WHEREAS, Article VI, Section 1(h) of the Constitution of the Tohono O'odham Nation vests the**  
2 **Tohono O'odham Legislative Council with the power to "enact laws and ordinances**  
3 **governing the enrollment and adoption of members and the relinquishment and loss**  
4 **of membership"; and**

5 **WHEREAS, in accordance with the Tohono O'odham Nation's Enrollment Ordinance, Ordinance**  
6 **No. 05-81, as amended, the Enrollment Committee has reviewed and recommends**  
7 **approval of the enrollment or adoption applications for the individuals identified in**  
8 **the March 2012 Membership Applications List, which is incorporated by this reference;**  
9 **and**

10 **WHEREAS, pursuant to Article VIII, Section 1(C)(1) and (2) of the Enrollment Ordinance,**

11 **The final determination as to whether an application for enrollment or**  
12 **adoption is approved or rejected by the Council shall be reduced to writing and**  
13 **approved by the Chairman of the Nation regarding each application for**  
14 **enrollment or adoption filed with the enrollment committee. Such**  
15 **determinations shall set forth the following findings of fact:**

- 16 **(1) If on an application for adoption, the date of applicant's birth, the degree of**  
17 **Papago-Tohono O'odham Indian blood ascribed to the applicant.**  
18 **(2) If on an application for enrollment, the date of applicant's birth, the**  
19 **membership requirement or requirements which the Council found the**  
20 **applicant did or failed to establish.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council has reviewed**  
22 **the Enrollment Committee's recommendations and approves the applications for**  
23 **enrollment or adoption that are identified in the March 2012 Membership**  
24 **Applications List, which includes the name, date of birth, enrollment number, and**  
25 **membership requirement or, for adoption, the degree of Papago-Tohono O'odham**  
26 **Indian blood for each applicant.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14<sup>TH</sup> Day**  
28 **of MARCH, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**  
29 **AGAINST; [02] NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**  
30 **Article II, Section 1 (a)or(b)and Section 2 and Article VI, Section 1 (h) of the Constitution of the**  
31 **Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and**  
32 **approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,**  
33 **pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
