3	WHEREAS, the Executive Office of the Chairman submits for review and approval the FY2012
4	Budget Amendment No. 1; and
5	WHEREAS, the FY2012 Audit Provisions Budget is hereby amended increasing the budget by
6	\$124,000.00 to cover additional costs to complete District Audits for San Xavier District
7	for FY2006, FY2007, FY2008, FY2009, FY2010 and FY2011; and
8	WHEREAS, the FY2012 Audit Provisions Budget Amendment No. 1 has been reviewed by the Budget
9	and Finance Committee.
10	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves
11	the Audit Provisions Budget Amendment No. 1 increasing the budget by \$124,000.00
12	and appropriates \$124,000.00 from General Surplus Fund.
13	BE IT FURTHER RESOLVED that no information disclosed in such district audits and no findings
14	of the auditors will be used to justify or support any legislative action to modify,
15	reduce or terminate the current distributive shares of Gaming Revenues or other
16	financial distributions or services afforded to any district, nor shall the cost of such
17	audits be charged to or assessed against any district subject thereto.
18	BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council hereby authorizes the
19	Chairman and any designated official to expend and administer the budget as
20	attached, provided that any amendments affecting the funds or funding level is
21	submitted for further prior approval by the Tohono O'odham Legislative Council.
22	The foregoing Resolution was defeated by the Tohono O'odham Legislative Council on the 15 TH Day
23	of <u>MARCH</u> , 2012 at a meeting at which a quorum was present with a vote of <u>215.80</u> FOR; <u>2,564.80</u> AGAINST; <u>[02]</u> NOT VOTING; and <u>[02]</u> ABSENT, pursuant to the powers vested in the Council by
24 25	Article VI Section 1(d)(2) of the Constitution of the Tohono O'odnam Nation, adopted by the
26	Tokono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
