1 **WHEREAS, the Tohono O'odham Nation Legislative Council approved the FY2012 Audit Provisions**
2 **Budget pursuant to Legislative Council Resolution No. 11-320; and**

3 **WHEREAS, the Executive Office of the Chairman submits for review and approval the FY2012**
4 **Budget Amendment No. 1; and**

5 **WHEREAS, the FY2012 Audit Provisions Budget is hereby amended increasing the budget by**
6 **\$124,000.00 to cover additional costs to complete District Audits for San Xavier District**
7 **for FY2006, FY2007, FY2008, FY2009, FY2010 and FY2011; and**


8 **WHEREAS, the FY2012 Audit Provisions Budget Amendment No. 1 has been reviewed by the Budget**
9 **and Finance Committee.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
11 **the Audit Provisions Budget Amendment No. 1 increasing the budget by \$124,000.00**
12 **and appropriates \$124,000.00 from General Surplus Fund.**

13 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes the**
14 **Chairman and any designated official to expend and administer the budget as**
15 **attached, provided that any amendments affecting the funds or funding level is**
16 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15TH Day**
18 **of MARCH, 2012 at a meeting at which a quorum was present with a vote of 2,564.80 FOR; 215.80**
19 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article**
20 **VI, Section 1 (d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
21 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
22 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
23 **Stat. 984).**
