

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Recognizing the San Xavier District Council Appointment of Rachael Vilson-Stoner as
Alternate to Legislative Representative Hilarion Campus)

LEGISLATIVE ORDER NO. 12-092

1 **WHEREAS, the Constitution of the Tohono O'odham Nation empowers the Legislative Council to**
2 **"enact laws and ordinances for conducting and regulating elections" and provides**
3 **that the "decision of the Tohono O'odham Council in all election matters, including**
4 **the eligibility and qualifications of candidates, shall be final" (Constitution, Article VI,**
5 **Section 1(g) and Article X, Section 7); and**

6 **WHEREAS, during the May 28, 2011 general election Hilarion Campus was elected to the open**
7 **Legislative Council representative seat for the San Xavier District but the alternate**
8 **representative seat remained vacant; and**


9 **WHEREAS, on March 6, 2012, the San Xavier District Council appointed Rachael Vilson-Stoner to**
10 **serve as Representative Hilarion Campus' alternate on the Legislative Council (San**
11 **Xavier District Council Resolution No. SXDC 03-12-01); and**

12 **WHEREAS, the Legislative Council, as a means of ensuring that each district is fully represented**
13 **on the Legislative Council, has recognized district council appointments to vacant**
14 **alternate seats in instances where vacancies have occurred outside of provisions**
15 **expressly outlined in the Uniform Election Ordinance for filling vacancies.**

16 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that (1) it hereby**
17 **recognizes the San Xavier District Council appointment of Rachael Vilson-Stoner to**
18 **serve as alternate to Legislative Council Representative Hilarion Campus and (2) seats**
19 **alternate Representative Rachael Vilson-Stoner, who shall serve in accordance with**
20 **the Constitution and laws of the Tohono O'odham Nation and with the rules and**
21 **procedures of the Legislative Council when Representative Hilarion Campus is unable**
22 **to attend a Legislative Council session.**

23 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 15TH day of**
24 **MARCH, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**
25 **-0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI,**
26 **Section 1(g) and Article X, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by**
27 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
29 **18, 1934 (48 Stat. 984).**


