

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Recognition of Relinquishment from membership in the Tohono O'odham Nation**  
**for the month of April 2012)**

**RESOLUTION NO. 12-096**

1 **WHEREAS, Article VI, Section 1(h) of the Constitution of the Tohono O'odham Nation vests the**  
2 **Tohono O'odham Legislative Council with the power to “enact laws and ordinances**  
3 **governing the enrollment and adoption of members and the relinquishment and loss**  
4 **of membership”; and**

5 **WHEREAS, in accordance with the Tohono O'odham Nation’s Enrollment Ordinance, Ordinance**  
6 **No. 05-81, as amended, the Enrollment Committee has received a written statement**  
7 **from 1 tribal member who has expressed an intent to relinquish membership with the**  
8 **Tohono O'odham Nation and the member is identified in the April 2012**  
9 **Relinquishment List, which is incorporated by this reference; and**

10 **WHEREAS, pursuant to Article IX, Section 1 of the Enrollment Ordinance,**  
11 **A member of the Nation may relinquish his membership in the Nation by submitting**  
12 **a written statement clearly expressing an intent to relinquish his membership to the**  
13 **Council, a copy of which must be served on the committee. The written statement**  
14 **must be signed by the person wishing to relinquish his membership or, if a minor or**  
15 **incompetent, by the parent(s), guardian or other person legally authorized to act on**  
16 **his behalf. Relinquishment does not require the approval of the Council, but is**  
17 **effective upon receipt of the statement by the Council and cannot be subsequently**  
18 **denied. Upon recognition by the Council that the individual has renounced his**  
19 **membership, his name shall be deleted from the membership roll.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
21 **recognizes that the individuals identified in the April 2012 Relinquishment List have**  
22 **relinquished their membership in the Tohono O'odham Nation and orders the**  
23 **removal of their names from the Nation’s membership roll.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09<sup>TH</sup> Day**  
25 **of APRIL, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**  
26 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article**  
27 **VI, Section 1 (h) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
28 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
29 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
30 **Stat. 984).**
