**RESOLUTION NO. 12-104**

1 **WHEREAS, the Tohono O'odham Legislative Council approved the FY2012 Magdalena Visitor**  
2 **Center Project Budget to Legislative Council Resolution No. 11-320; and**

3 **WHEREAS, the Office of the Chairman submits for review and approval FY2012 Budget**  
4 **Amendment No. 1; and**

5 **WHEREAS, the FY 2012 Amendment #1 was prepared to create line items 6005 - Occasional**  
6 **Appointment and 6200 - Fringe Benefits; and decreasing 7355 - Professional Services -**  
7 **6530 Travel Expense; and**

8 **WHEREAS, FY 2012 Magdalena Visitor Center Budget will remain at current approved budget**  
9 **amount of \$20,575.00; and**


10 **WHEREAS, the FY 2012 Magdalena Visitor Center Project Budget has been reviewed by the Budget**  
11 **and Finance Committee of the Legislative Council have reviewed this Budget**  
12 **amendment and recommend its approval and adoption.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council hereby**  
14 **approves Amendment #1 to create line items 6005 - Occasional Appointment and 6200**  
15 **- Fringe Benefits; decreasing 7355 - Professional Services and 6530 - Travel Expense.**  
16 **FY 2012 Magdalena Visitor Center Budget will remain at current approved budget**  
17 **amount of \$20,575.00.**

18 **BE IT FINALLY RESOLVED that the Tohono O'Odham Legislative Council hereby authorizes the**  
19 **Chairperson and any designated official to expend and administer the budget, as**  
20 **attached, provided that any amendments affecting the funds of funding levels of the**  
21 **budget shall be submitted for further prior approval by the Tohono O'odham**  
22 **Legislative Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09<sup>TH</sup> Day**  
24 **of APRIL, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**  
25 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article**  
26 **VI, Section 1 (d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
27 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
28 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
29 **Stat. 984).**


