LEGISLATIVE ORDER NO. 12-105

1	WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "establish rules
2	and procedures to regulate all meetings of the Tohono O'odham Council" pursuant to
3	Section 1(a) of Article VI of the Constitution of the Tohono O'odham Nation; and
4	WHEREAS, the Legislative Council has adopted Legislative Rules requiring that "Prior to an
5	official adjournment, the Legislative Council shall adopt a legislative calendar which
6	shall commence on the first working day of June on which the Legislative Council shall
7	be called into Legislative Session; provided that, in a general election year, the
8	legislative calendar shall commence on the first Monday in June that is at least ten
9	days after the Election Board is required to issue its Certificate of Election Results"
10	(Legislative Rules of the Tohono O'odham Legislative Council, Article I, Section 1.A.1);

12	WHEREAS, the Tohono O'odham Legislative Rules Committee has been charged with developing
13	the Legislative Council Calendar for the 2012-2013 Legislative Session; and
14	WHEREAS, the Rules Committee has developed a "Tohono O'odham Legislative Council Calendar
15	June 2012 - June 2013" with adjournment dates beginning May 28, 2013 and concluding
16	June 11, 2013 and recommends its adoption.
17	NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that,
18	notwithstanding Legislative Rules, Article I, Section 1, the Legislative Council adopts
19	the attached "Tohono O'odham Legislative Council Calendar June 2012 - June 2013."
