

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Adopting Tohono O'odham Legislative Council Calendar June 2012 - June 2013)**

**LEGISLATIVE ORDER NO. 12-105**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "establish rules**  
2 **and procedures to regulate all meetings of the Tohono O'odham Council" pursuant to**  
3 **Section 1(a) of Article VI of the Constitution of the Tohono O'odham Nation; and**

4 **WHEREAS, the Legislative Council has adopted Legislative Rules requiring that "Prior to an**  
5 **official adjournment, the Legislative Council shall adopt a legislative calendar which**  
6 **shall commence on the first working day of June on which the Legislative Council shall**  
7 **be called into Legislative Session; provided that, in a general election year, the**  
8 **legislative calendar shall commence on the first Monday in June that is at least ten**  
9 **days after the Election Board is required to issue its Certificate of Election Results..."**  
10 **(Legislative Rules of the Tohono O'odham Legislative Council, Article I, Section 1.A.1);**  
11 **and**

12 **WHEREAS, the Tohono O'odham Legislative Rules Committee has been charged with developing**  
13 **the Legislative Council Calendar for the 2012-2013 Legislative Session; and**

14 **WHEREAS, the Rules Committee has developed a "Tohono O'odham Legislative Council Calendar**  
15 **June 2012 - June 2013" with adjournment dates beginning May 28, 2013 and concluding**  
16 **June 11, 2013 and recommends its adoption.**

17 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that,**  
18 **notwithstanding Legislative Rules, Article I, Section 1, the Legislative Council adopts**  
19 **the attached "Tohono O'odham Legislative Council Calendar June 2012 - June 2013."**

20 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 09<sup>TH</sup> day of**  
21 **APRIL, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**  
22 **-0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article VI,**  
23 **Section 1(a) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham**  
24 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
25 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


